## Release and Waiver of Liability and Indemnity Agreement

**ALL TEAM MEMBERS MUST SIGN BELOW WITH THE UNDERSTANDING AND AGREEMENT OF THE WAIVER AS PRESENTED**

In consideration of being permitted to participate in the Hurt Ink Tattoo Dodgeball Tournament Fundraiser presented by YOUth CARES, the undersigned below HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT not to sue the Concho Valley CARES Coalition, YOUth CARES Teen Committee, Alcohol & Drug Abuse Council for the Concho Valley, volunteers, employees, promoters, other participants, operators, officials, sponsors, advertisers, owners (San Angelo ISD) of premises used to conduct the event, and each of their officers and employees, all for the purpose herein referred to as "releases", from all liability to the undersigned, his personal representatives, heirs and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is competing, officiating, observing, working or for any purpose participating in the event.

HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases and each of them for any loss, liability, damage, or cost they may incur due to the presence of the undersigned in any way competing, officiating, observing, working or for any purpose participating in the event and whether caused by the negligence of the releases or otherwise.

HEREBY ASSUMES FULL RESPONSIBILITY FOR A RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due the negligence of releases or otherwise while in any way competing, officiating, observing, working or for any purpose participating in the event.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities could be dangerous and involve the risk of serious injury and/or death and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that the forgoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by laws of the State of Texas. It is agreed that the balance shall, not with standing, continue, in full legal force and effect.

**THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**, and further agrees that no oral representation, statements or inducements apart from the foregoing written agreement have been made.

### FOR PARTICIPANTS UNDER THE AGE OF 18—RELEASE AND CONSENT FORM

Being the parent and/or legal guardian of the undersigned I hereby consent to permit my child to enter and/or participate in the Hurt Ink Tattoo Dodgeball Tournament Fundraiser presented by YOUth CARES being held at Lincoln Middle School, and that said minor is under the legal age of the State of Texas. I hereby expressly release both the producer and sponsor and all their associates for any injuries of any kind or nature which may occur or be received as a result of said minor's participation in the Dodgeball Tournament. I hereby expressly waive all claim for injuries that may occur should said minor be injured while being a contestant in the Title Sponsor Dodgeball Tournament Fundraiser presented by YOUth CARES.
